What is the Children Law Accreditation Scheme?

The Children Law Accreditation Scheme covers all types of children law work. Members will have shown, to the satisfaction of the Law Society, that they have and will maintain a high level of knowledge, skills, experience and practice in the area of children law, be that in private practice or working for a local authority. There are two types of membership;

1) Children Representative – Assessed as skilled to represent children in all family proceedings where there is provision to represent children, and adult parties in public law proceedings under the Children Act 1989.

2) Adult party Representative – Assessed as skilled to represent of adult parties in public law proceedings under the Children Act 1989.

All of the above are Children Representative members of the Accreditation scheme except for; David Howell Richardson, Emma Outram, Sue Jury, Darren Cleverdon, Lindsey Jackson, Nigel Treasden, who are Adult party representatives.
